## 1 Weight and container categories

The following container weights are net weights (goods incl. packaging) and are excl. container tare weight.

**20' ct A:** 20 ft DV/OT in gauge container < 14.5 t excl. tare / 16,5 t incl. tare

**20' ct A:** 20 ft DV/OT in gauge container < 24 t excl. tare / 26 t incl. tare

**20' ct A:** 20 ft DV/OT in gauge container < 28 t excl. tare / 30 t incl. tare

**Oversized 20' containers are treated like 40' containers, e.g., 20' tank containers with swap body.**

**40' ct:** 40 ft DV/HC/OT in gauge container < 24 t excl. tare / 28 t incl. tare

**40' ct:** 40 ft DV/HC/OT in gauge container < 26 t excl. tare / 30 t incl. tare

**45' ct:** 45 ft container < 24 t excl. tare / 28 t incl. tare

**45' ct:** 45 ft container < 26 t excl. tare / 30 t incl. tare

The following average empty container weights (tare) are defined in our logistics software for processing purposes:

#### 6. Fuel surcharge

**Note:** The rail facilities of the port companies are subject to the ISPS Code / Port Security Ordinance. According to this regulation, full containers must be sealed at the entrance. If there are unsealed containers on an incoming train, these must be resealed at a charge or it must be assumed that the loading unit was broken open during transportation and acceptance is then refused. The costs can be avoided by sealing the containers in domestic combined transport, see 2.1.15 & 16.
