1 Weight and container categories

20' ct A:	20 ft DV/HC/OT in gauge < 11 t excl. tare
20' ct B:	20 ft DV/HC/OT in gauge < 24 t excl. tare
20' ct C:	20 ft DV/HC/OT in gauge < 28 t excl. tare
40' ct:	40 ft DV/HC/OT in gauge container < 22 t excl. tare
40' ct:	40 ft DV/HC/OT in gauge container < 26 t excl. tare
45' ct:	45 ft container < 22 t excl. tare
45' ct:	45 ft container < 26 t excl. tare

The following average empty container weights (tare) are defined in our logistics software for processing purposes:

20' ct empty:	2 t
40' ct empty:	4 t
45' ct empty:	4.5 t

1. 20' combinations (2 x 20' containers on one chassis)

Combinations of 2 x 20' containers are possible as long as the permissible total weight of the vehicle is considered. 20' containers destined to be X-ray checked and / or presented at the veterinary office are excluded. Also excluded are 20' containers with multi-stop / customs stop during transport. The combination of 20' containers with dangerous goods is possible but needs to be requested in advance.

2. Definition of local & long-distance transport

- a. **Local transport:** transport distance \leq 150 km in one direction
- b. **Long-distance transport:** transport distance < 150 km in one direction

2 Fees for road services

1. Transport of 45' ct for local Hamburg traffic is **not possible**
2. Transport surcharge for **45' ct for long-distance traffic not possible**
3. Infrastructure surcharge for Bremerhaven, Wilhelmshaven and Hamburg:

This surcharge is set **quarterly** and applies **per container in each direction**. The current surcharge rate can be found on the homepage of our online tariff calculator and in the service catalogues. The surcharge rate for the following quarter is announced via customer email once it has been determined.

4. Fuel surcharge

This surcharge is set **monthly** and is calculated as a percentage of the basic freight.
